- Hopeful for a discussion regarding public awareness about leaving campfires unattended throughout the Mono Basin (Glenda)
 - Will provide an update on dispersed camping and fire safety fliers (Robbie)
- Will there be a brush bin in Mono City? (Jeff)
 - Bin courtesy of Mono City Fire Commissioners and Dave Swisher (John)

• CalFire grant, with Holly Alpert

- Robbie and Lia Webb participated in larger collaborative discussion with Holly to identify opportunities that might exist
 - Holly is leading the charge
 - MBFSC offered to review the grant application as well as write a letter in support
- Grant through the Sierra Nevada Conservancy focused on capacity building, project planning, and starting to get stuff funded
 - Governor passed over \$500m for fire prevention and protection; with agencies now soliciting projects for grants
- o CalFire forest health solicitation focused on forested areas
- CalFire fire prevention solicitation
 - Focus on Education; Developing community wildfire protection plans; Fuels reduction
 - Holly is writing proposals for all three
 - Attention to the first, with a two-fold approach with focus on educating visitors about fire prevention
 - (1) Develop printed materials for the region with a common look and branding with messaging about fire prevention, campfires, communicating fire restrictions
 - Fliers in fire wood bundles; sandwich boards; billboards; posters to put up at visitor centers
 - (2) In person education & outreach: targeting dispersed campers, campgrounds, tabling at visitor centers, events focused on visitors (e.g., fishing opener)
 - Region: all of Alpine and Mono counties; Inyo County west of Owens Valley
 - Grant awarded this Fall, with a timeline through Spring of 2025 (Efforts target summer seasons of 2022-24 and winter)

Discussion

Training volunteers; Adopt a campground with vest (Connie)

- Alex Ertaud, of Friends of the Inyo, is leading stewardship initiatives with roving volunteers to provide info in a polite way; Dispersed camping education outreach with Alicia Vennos (Bob)
- Important to coordinate, not to compete with multiple efforts (Holly)
- Use of social media: Instagram and QR codes (John)
- Eastern wildfire alliance website; Stories in local media a possibility (Holly)
- Mono County can have branded efforts, and from this grant its own branding of messages that aim at the same goal (Robbie)
- Lia doing research to push forward and manage social media campaigns over three years; pricing that into budget (Robbie & Holly)

Mono City fire breaks

- o Fuels reduction is another focus of the CalFire fire prevention solicitation (Holly)
 - Working with Inyo National Forest to identify areas around communities
 - Mono City
 - Mowing of shrubs (maintenance, 3-5 year cycle)
 - Thinning of riparian vegetation
- Ana Maria working with Gordon Martin to communicate concerns to Forest Service on need for fuels reduction above and below Mono City; attention also to fire modeling (Robbie)
 - Early Spring, before nesting season, or late Fall before snow to tackle fire breaks (Robbie)
 - Will follow up with Ana Maria (Robbie)

MBFSC webpage & Facebook

- Discussion of how to update and seek to maintain the webpage
 - Webpage updates can be made by Chance
- Vision of one place, with organized infrastructure, and constant updates (Robbie)
- Working closely with Holly to build capacity in Eastern Sierra for projects like this (Chance)
 - Need to get people together to sustain such a resource in the long term
- Discussion
 - Focus first on things like fire restrictions, but also links to information about emergencies and safety (Robbie)
 - Work with various agencies to automatically send info to a point person (Margaret)
 - Get MBFSC on lists, and have public information officers send press releases (Robbie)
 - For latest fire updates, contact interagency fire dispatch in Bishop (Gary)
 - Challenge is how timely you want the information to be (Bob)
 - Could assign person/s to perform weekly check of agency calls & websites, and then funnel info to Chance (Robbie)
 - Attention to just the Mono Basin, so not an onerous job of who to contact (Connie)

- Chance as the point person looking and receiving info, with others chiming in about what they found (Bob)
- Work with Chance, and bring webpage changes back to group for review (Robbie)
- Working with local agencies with long term project timelines, making it easier to access pertinent information (Chance)
- Another idea: Maybe have signs like the Forest Service, indicating fire danger [low, moderate, high, extreme] (Bob)
 - CalFire education grant proposal to include a request for mobile electronic messaging signs (Holly)
- Facebook plans
 - Could the FSC have a Facebook page linking back to the webpage? (Robbie)
 - How to manage and upkeep?
 - Weekly posts on Facebook and Instagram to attract attention, and funnel interest back to the webpage (John)
- Lee Vining FD access to SCE gated areas
 - No action yet taken (Tom and Santiago)
 - Attention to gates that can be double-locked for LVFD and SCE
 - Asked SCE to remove boulders and replace with double-locked gates
 - o In talks with Cal Rossi at SCE; Official request letter submitted by Paul McFarland; SCE to move as soon as possible (Bob)
- Fire Safety banner
 - o Recruit volunteer to help reposition truck and banner at Tioga Green (Robbie)
 - Look into a new location on SCE land to attract attention of northbound traffic (Bob)
 - Will reach out to Cal Rossi
 - Truck should move when it doesn't have a banner on it... why at a cannabis store?
 (Connie)
 - Second banner across from Mono Cone on the CalTrans fence? Hess Park? (John)
 - Potential for banner locations and engagement may be of value with the education plans and branded materials for the CalFire grant (Robbie)
 - Another banner for traffic coming down the Tioga Road/Hwy 120? (Connie)
 - Will reach out to Megan Maloney about locations or an old truck
- Fire Safety fliers
 - o Interest in doing but no action taken yet (Robbie)
 - Succinct messaging; not like Forest Service overload of information
 - Action item; Will create a draft for everyone to review
 - Send file to Bob for printing
 - Get volunteers to distribute (Tom)
 - Have a dozen laminated copies or thicker paper so they don't blow away
 - Could include paper leaflets in firewood bundles, as part of outreach branding (Robbie)
